C2E2'S POWER UP TO READ

(the "Sweepstakes") Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

This Sweepstakes is being held in connection with Chicago Comic & Entertainment Expo at McCormick Place, Chicago, Illinois scheduled to take place from April 11, 2025through April 13, 2025 (the "Event").

- **1. SWEEPSTAKES PERIOD:** The Sweepstakes begins at 9:00 a.m. CT on December 13, 2024 and ends at 5:00 p.m. CT on March 26, 2025 (the "Sweepstakes Period").
- **2. Headings and captions are used in these Official Rules solely for convenience and ease of reference and shall not be deemed to affect in any manner the meaning or intent of these Official Rules or any provision hereof.

6. All Participants are expected to review the Privacy Policy carefully before participating in the Sweepstakes and each Participant acknowledges that, in the event of a conflict or inconsistency between the terms of these Official Rules and the terms of the Privacy Policy, the terms of the Privacy Policy shall prevail, govern and control.
